

# Annual Review







Essex Community Foundation (ECF) is an independent charitable trust set up in 1996 by a local family inspired by a vision to create a permanent financial resource to support voluntary organisations in their home county. Their ambition continues to guide us today.

Over nearly three decades we have expanded our work with individuals, families, businesses, charitable trusts and public agenices, introducing them to local groups tackling issues in our communities. By investing the donations we receive and the funds we manage, we provide a sustainable source of funding that local organisations can access year after year.

We have become a trusted leader in the voluntary and community sector by carrying out due diligence on funding applications and matching the needs of charities and individuals with the priorities of our donors. We award around £4 million in grants each year which reflects a genuine impact on organisations and the wider community.

### From our Chair

#### Nick Alston CBE DL Chair of Trustees

It is a great pleasure to introduce our 2025 Annual Review. This is my seventh and final year as Chair of Trustees, and it has been an enormous privilege. I am so proud to have worked alongside such passionate trustees, talented staff, inspiring partners and committed supporters.

People have always been at the heart of Essex Community Foundation, those who give, who care, and who step forward time and again to help build a fairer, kinder and more connected county. On behalf of all trustees, thank you for your support, energy and belief in what we do.

Our year began with the launch of our bold 2030 Strategy, created with input from a wide range of partners. It has already brought fresh energy, growth and momentum, while challenging us to respond to the realities of a world increasingly shaped by economic uncertainty and growing inequalities.

We've been listening more closely than ever to the voices of local people and organisations. Through our Community Listening Projects and county-wide Symposia, we've gathered first-hand insight into the needs, priorities and aspirations of communities across Essex. This work has informed our research showing that the voluntary sector in our county contributes over £1 billion to the economy, employs 17,500 people and mobilises 95,000 volunteers.

As a result, a new strand of our work is to champion the voice of civil society. This year we brought together 15 countywide voluntary and community support

organisations as the Devolution and Local Government Reorganisation Roundtable. Together we issued a joint statement urging recognition of the sector's role in this process. We are proud that Community Foundations are increasingly recognised nationally as leaders in this space, with representatives, including our CEO, Caroline Taylor, joining the Prime Minister, civil society leaders and senior ministers at the launch of the new Civil Society Covenant in July.

At the same time, our core purpose remains unchanged: inspiring philanthropy and supporting grassroots organisations. Today we manage an endowment of £54.5 million, steward more than 200 charitable funds, and have awarded over £60 million in grants since we were founded in 1996. The use of our Foundation Hub at our premises in Chelmsford has increased by 200% providing groups we support with meeting or desk space free of charge.

As we look ahead to our 30th anniversary in 2026, we celebrate '30 Years of Generosity' – honouring those who built this Foundation, sharing stories of impact, and inviting new philanthropists and partners to join us.

I warmly welcome Atul Manek as our next Chair of Trustees. Atul joined ECF as a Trustee in 2022. I know the Foundation will continue to thrive with his leadership and generosity. Thank you to everyone who has supported our journey – our best years are still to come.

# A year of change and opportunity for Essex

#### Shaping a positive future

This year has brought important discussions that will lead to major changes for Essex.

Three reforms will reshape the way local charities and voluntary organisations work in their communities:

- Devolution the creation of a new Mayor for Essex and Combined Authority.
- Local Government
   Reorganisation (LGR) the
   move to new unitary authorities.
- Integrated Care Board (ICB)
   restructuring merger of 3
   ICBs into one countywide
   that will focus on prevention,
   neighbourhood health, and
   community-led care.

This is a critical moment for Essex, where voluntary organisations are working within a challenging landscape. 96% are facing rising costs and 81% report falling income, forcing many to rethink how they can sustain vital services.

These reforms bring both opportunity and risk. With strong community involvement, they could deliver more local democracy and services that are shaped around people's lives. Without it, decision-making may become too centralised, weakening the networks that hold our county together.

These changes underline why our 2030 Strategy places such emphasis on becoming a bold, leading voice for the voluntary sector.

By championing the collective insights and experience of local charities, we will ensure they are included as Essex takes important decisions about its future.

## Strategic Ambition 2030

Be a bold independent voice for the voluntary sector, encouraging increased levels of collaboration and influence. **A. Amplifying voices:** use our trusted independent local insight to champion and highlight the value of the voluntary sector to decision-makers in, and beyond Essex.

**B. Advocacy and influence:** Use our knowledge sand connections to influence and improve how the public and private sectors collaborate with the voluntary sector.

**C. Strong collaboration:** Help unite and strengthen the voluntary sector in Essex through supporting infrastructure, convening, match-making, facilitated learning and information sharing.

As part of our commitment to the policy and advocacy work of our 2030 Strategy, this year we have embraced our role as a leading voice in our community, taking on the responsibility of amplifying the voices of local charities and advocating on their behalf across Essex.

To support this, we created the Devolution and Local Government Reorganisation Roundtable, made up of county wide support organisations. Together we have published joint statements that demonstrate the impact of the sector in shaping future policy, and we have asked for five core principles:

- 1. Local governance that reflects real communities
- 2. A formal role for the VCS in governance and transition
- 3. Long-term investment in place-based support
- 4. Simplified, collaborative commissioning
- 5. Integration with health, care and public service reform

These principles are rooted in the experience of community organisations across Essex and align with the ambitions set out in the Civil Society Covenant, the Caring Communities Commission, and the NHS 10-Year Health Plan. This important work has been positively received and widely cited in council briefings, local board meetings and by national bodies.

## Working with public sector partners

Collaboration has extended beyond our sector. The Caring Communities Commission, created to respond to growing pressures on social and care services, has set out an ambitious vision for the future of Essex. We have been able to highlight the importance of delivering its recommendations, which recognise the voluntary sector's vital role in prevention and resilience.

Our work has ensured that voluntary voices are at the table in ongoing discussions with Essex County Council, other local authorities, health partners and MPs, strengthening the case for community-led solutions.

# Local philanthropy in action Supporting our voluntary sector 2024-25



Thank you to everyone who has helped us to be able to pay an incredible £3.8 million in grants this year to 549 organisations and 167 individuals, a 12% increase on last year.

Our funding supports a wide range of voluntary and community groups across Essex helping them respond to rising demand, strengthen resilience, and continue vital community work.

We know that receiving funding over multiple years enables organisaions to plan and build capacity and this year we

significantly increased the amount we awarded to £815,738. These grants now account for 22% of our overall grantmaking, providing stability for organisations facing unpredictable costs and growing demand.

Core funding also remained a priority, with 34% of our grantmaking supporting group's operational costs including staffing, rent, and utilities, helping charities retain staff, maintain services, and plan ahead.

We actively promote the availability of grants, so that groups we have not funded before can find out about us. This year, first-time applicants received grants totalling £280,669. Smaller charities remain a focus with 14% of grants awarded to organisations with incomes under £25,000.

**Age Concern Southend-on-Sea** provides a hub and outreach services for older people. It is a lifeline in the community, helping to reduce isolation, encourage physical activities, improve mental and emotional wellbeing as well as offering a meeting place which is brimming with activities and support.

Funding to organisations working with marginalised or underrepresented groups totalled £446,312 across 42 grants, including support for refugees, ethnic minorities, LGBTQ+ people, and those affected by addiction, domestic abuse, or the criminal justice system. This included delivery of the Homes for Ukraine Community Grants Programme, in partnership with Essex County Council.

# Supporting transformative change

Occasionally, we can give a substantive grant to a project that will bring lasting, transformative change to local communities. This year, one such opportunity came when CHESS Homeless, a Chelmsford-based charity, set out to create a new modular housing development for people experiencing homelessness and vulnerability.

a reality thanks to a grant of £427,418 from the **William and Gladys Pudney Memorial Fund**. The Fund, established in 2017, supports vulnerable people and housing related projects in Chelmsford and Writtle. This significant gift provided the cornerstone funding needed for CHESS Homeless to unlock

additional support from the Government's Single Homeless Accommodation Programme (SHAP), ensuring the project could move forward.

The new site, named Turning Point, was officially unveiled in April at a special event attended by Jennifer Tolhurst, Lord Lieutenant of Essex and Patron of ECF, alongside the Mayor of Chelmsford, the High Sheriff of Essex Julie Fosh, and representatives from Essex County and Chelmsford City Councils.

Purpose-built and modular in design, Turning Point will provide safe and supportive accommodation for 24 individuals. More than shelter, it offers a vital foundation for people to rebuild their lives. Residents will have access to

#### Investing in safer communities



Safer communities are important to all of us. This year we awarded £203,436 to 34 charities and voluntary groups for work and projects that contribute to community safety in Essex. This included £30,000 presented by the High Sheriff of Essex, Mr David Hurst DL.

The Essex Police Proceeds of Crime Matched Funding Scheme, established by Essex Police in 2014, enables us to match fund eligible donations and establish funds to support charities and voluntary groups whose work is contributing to safer communities

Funds set up with matched funding this year include:

#### **Anderson Family Fund**

Denis Anderson was introduced to us by a friend and supporter of ECF. He wanted to set up a fund in the name of his family and by utilising matched funding from the Proceeds of Crime Scheme, it is helping his fund to grow more quickly.

#### Essex Agricultural Society Community Fund

For over 150 years the Essex Agricultural Society has supported the rural community in Essex. Establishing their fund will ensure they can keep providing support to rural based charities and community projects, with an emphasis on educating the next generation around rural safety, as well as highlighting where food originates from.

### Essex New Beginnings Fund

This year, Chelmsford Crown Court established a Fund to support charities and voluntary groups working within the jurisdiction of the Court with a preference of funding those whose work is providing education, training and diversionary activities for young people and those supporting people affected by homelessness.

Money is added to the Fund from cases heard by the Court and where assets are acquired under

the Misuse of Drugs Act or from forfeiture orders where money or other property is seized because it is suspected to be related to criminal activity.

#### Did you know?

If you set up an endowed fund, you can also make donations that are available to spend during the year. We call this a Hybrid Fund and is allows you to make grants while your invested fund is growing.

### Transferring a Trust to us

We are always pleased to help trustees of existing trusts if they are struggling to find beneficiaries, unable to find new trustees, their objectives are outdated or they just feel the time is right to hand over the administration. Trustees can remain involved with the grantmaking if this is what they want.

This year, we welcomed several trusts, ensuring their original charitable intentions live on with renewed impact.

#### **Rob George Foundation**

After more than a decade of supporting young people across the UK, the Rob George Foundation (RGF) secured its long-term future by transferring its operations to us.

RGF was founded by Philip and Lorraine George in January 2014 in memory of their son, Rob, an accomplished sportsman and Colchester Royal Grammar School student who died aged just 21 after facing acute myeloid leukaemia with remarkable courage and resilience. Since then, the Trust has provided over £1 million in grants and supported more than 1,700 young people facing lifethreatening illnesses or pursuing excellence in sport and the performing arts.





#### John & Amy English Charity

The John & Amy English Charity's origins date back to 1764. When the trustees of the Charity contacted us about taking on the trust, we were pleased to have a conversation. The Trust is dedicated to supporting children and young people in Mountnessing and surrounding areas. It provides grants to local charities, voluntary groups, and individuals working to improve young lives.

The original founder, Richard Bayley, envisioned a school for disadvantaged children. His daughter Amy, with her husband John English, fulfilled that wish by using farm profits to fund education. Transferring the long-established trust to us ensures it will continue to support young people as Richard, John and Amy had always intended.

This year, we were pleased to work with the Trustees of the 'Roxwell Charities for the Poor' and the 'Writtle Relief in Need' charities to transfer the trusts to our management and set up charitable funds to ensure their future and continue to support voluntary groups and individuals in these communities.

## Get started with our Fundbuilder Scheme

Our Fundbuilder scheme makes it possible for individuals, families, and businesses to grow a fund over time. By making regular donations, you can gradually build a permanent legacy that reflects your priorities and passions.

While the funds are growing, the donations from all fundbuilder donors are pooled into a collective fund. We award grants annually from this fund enabling donors to see their contributions making an immediate impact, while their individual funds continue to grow for future long-term giving. Once individual donations reach £25,000 these can be moved to set up a standalone fund if the donor wishes.

This year, we welcomed three new donors who are growing their charitable funds under our fundbuilder scheme - the Newenham Family Fund, the Johnson Family Fund and the Saffron Fund.

The Wright Fund also became our first standalone fund to be established. Having spent most of their lives in Essex, Jane and Edward Wright recently retired in Wivenhoe. Though they knew they wouldn't have vast funds at their disposal, they always wanted to make a meaningful difference in their lifetime. Fundbuilder enabled them to grow their fund at a pace that worked for them.

**3Food4U** based in Waltham Abbey received a grant of £5,000, including £1,352 from our **Fundbuilder Fund**, enabling them to provide emergency food, essential toiletries and household items to people in need.

#### Leave a Legacy

Leaving a legacy in your will is straightforward and one of the most powerful ways to make a lasting impact. You can ensure that your values live on and your generosity continues to benefit the causes and communities you care about.

# Community spotlight – poverty and disadvantage

This year, we saw an increase in the number of grants paid to charities helping people who are struggling to manage in everyday life.

These grants totalled £666,452 and include projects that offer a support to those who are in difficult

circumstances, including families who are juggling rent arrears and food insecurity, older people who have fallen into debt and temporary accommodation and advocacy for those who are homeless.

#### **FACTS**

- Deprivation is most acute in coastal towns: 31% of residents in Clacton and Harwich (44,000 people) and 23% in Southend (40,800 people).
- In Tendring, Harlow and Basildon, nearly 1 in 3 children are eligible for Free School Meals
- **55%** of households in Tendring District have a discretionary income of less than £125 per month.

### Families under pressure

Without an appropriate school uniform, children can often experience feelings of isolation and bullying. **Dynamic New Anglian Networks** based in Colchester run

projects aimed at helping anyone who is in need through hardship or circumstance. We supported their Free School Uniform project which provides low-income families in Colchester with recycled school uniforms and sportswear, ensuring that children can be confident when they attend school.

#### Welfare advice

Since 1985, the dedicated staff and volunteers at **DIAL South Essex** have been providing support, advice, guidance and advocacy to people with disabilities, helping them on a range of topics including benefits, signposting, referrals, leisure and access. We supported the core costs of this vital organisation with a grant of £10,000.

#### Giving practical Support

A grant of £4,950 to **Maldon & District Community Voluntary Services** enabled them to continue running their emergency response service for disadvantaged people across Maldon district, including those on low incomes, with mental health conditions or those facing housing instability.

This service provides one-off emergency support such as food, childcare items, cooking equipment and supermarket vouchers.

### Supporting Health and Wellbeing

Volunteers are key to delivering the **Food Cycle** project in Clacton organising food collections, preparing and cooking food and hosting a lunch. Every week they provide a nutritious three-course meal and create a welcoming environment for local people. including those who are vulnerable, living on low incomes, have longterm physical or mental health conditions, are homeless or are isolated and lonely. In 2024, the project also saved a massive 14,145kg of surplus food from going to waste.

# Helping people achieve their full potential

We manage a small number of charitable funds that support individuals who face barriers to reaching their full potential or who need assistance in overcoming personal challenges.

Where possible, we collaborate with charities, schools, and community organisations to identify those who would most benefit from our support. In the past year, we awarded 167 grants totalling £204,649.

These grants have contributed towards education and training in science, technology, engineering and matematics (STEM) subjects, the arts, and sports. They have also created opportunities to develop new skills and provided essential support for people facing financial pressures, as well as physical or mental health difficulties.

#### **Sports**

Sisters Jasmine (16) and Skye (17) Carter, from Basildon, are making waves on the international stage as members of the Junior GB Swimming Team.

In 2023, Skye travelled to the Commonwealth Youth Games in Trinidad and Tobago, where she won gold in the 50m freestyle. Jasmine is also building her career as a rising star, with both sisters balancing school, training, and competitions at the highest level.

The family has been supported by the **Essex and Southend Sports Charitable Fund** and the **Chrysalis Fund**, which helped cover the significant costs of training and qualifying competitions.

#### **Education**

The rising cost of education continues to place real pressure on students and their families. Recent research shows that the average

student now graduates with debts of over £45,000, creating barriers to opportunity.

Ahnaf Ahmed lives in Thurrock with his family and is studying to become a lawyer. The requirements of his degree course at the University of Law in London makes it difficult for him to get a parttime job. A grant from the Essex Education Fund of £2,700 helped him to buy a new laptop and contribute to his travel costs.



#### Music

William Mwengi Selamaj (18) from Clacton is a talented musician, playing both the saxophone and the guitar. He performs with the Essex Jazz Orchestra and is developing a strong reputation as a versatile young artist.

William received £500 from the **Essex Young Musician's Trust** to help cover the costs of joining the Essex Youth Orchestra Summer Tour in Germany. The experience gave him the chance to perform internationally, learn from peers, and grow as a musician.

#### Health

Tom Rayner (14) lives in Chelmsford with his mum. Tom has Down's syndrome and is awaiting an assessment for Autism and ADHD. Despite these challenges, he loves being active, especially running, though he is unable to run for long periods on his own.

Thanks to a £4,446 grant from the **Moody Fund**, Tom's family were able to buy an all-terrain three-wheel buggy, giving him the freedom to enjoy running outdoors with the right support.

#### **Arts**

Ameile Gruar (14) from Loughton has always had a passion for Ballroom and Latin dancing. Living with her mother and older brother, she has already won multiple Championship competitions and proudly represented Team GB.

To help her continue competing at national level, Ameile received £2,000 from the **Belinda Starling Memorial Fund** and the **Annabel and Gerald Malton Fund**. This support covered the significant costs of lessons, dresses and shoes, ensuring Ameile can focus on dancing and reach her potential.

Her teacher said:

From a professional point of view, Ameile is one of the most talented children in our dance world at the moment. She is an incredibly hard worker, and has the drive to get to the top.

#### 4. Gateway Community Media


